Governments of the globe are using Common Reporting Standard ("CRS") for gathering and reporting information requirements for financial institutions. CRS is promulgated by the Organization for Economic Cooperation and Development ("OECD") which aims to put in place a global model of automatic exchange of financial account information ("AEOI") in the matters of taxation with a view to enhance tax transparency and combat cross-border tax evasion.

The Inland Revenue (Amendment) (No.3) Ordinance 2016 (the "Amendment Ordinance") which commenced operation on 30 June 2016 has put in place a legislative framework for Hong Kong to implement AEOI.

Under the Amendment Ordinance and AEOI standard, financial institutions are required to apply due diligence procedures to collect information and documentation of the customers and require them to provide to the financial institution with information about the customers' jurisdiction of tax residence including the relevant tax identification number (TIN). Required information of the accounts has to be collected and furnished to the Inland Revenue Department of Hong Kong ("IRD") and such information will be exchanged on annual basis. Financial institutions may request account holders to complete self-certification forms for verification of their tax residency status.

Accordingly, for any account open from 1 January 2017, Evergrande Securities and Evergrande Futures shall request the account holder to complete and sign an appropriate form of Self-Certification to confirm the account holder's tax residency and TIN and other relevant information. From 2018 and onwards, Evergrande Securities and Evergrande Futures shall report account information to the IRD on annual basis.

Individual customers should complete this form. Sole trader customers should also complete this form with the owner's information. For joint account holders, each individual will need to complete a separate form.

If the client's account was opened before 1 January 2017, Evergrande Securities and Evergrande Futures shall use the existing information available in the files to identify the client's tax residence. Evergrande Securities and Evergrande Futures may contact the client for further information by requesting the client to complete, sign and return to Evergrande Securities and Evergrande Futures a Self-Certification form to confirm the client's tax residency and TIN.

If you have any queries on how to define your tax residency status, please seek advice from your tax advisor as Evergrande Securities and Evergrande Futures are not allowed to give tax advice. If your circumstances change and any of the information provided in this form becomes incorrect, please let us know immediately and provide an updated self- certification.
